Point of Law: - PENAL CODE, 1860 - Sec.90 - 'Consent' - A consent given under fear / coercion or misconception / mistake of fact is not a consent at all - Consent is different from submission.

It can be held that a woman has given consent only if she has freely agreed to submit herself, while in free and unconstrained possession of her physical and moral power to act in a manner she wanted. Consent implies the exercise of a free and untrammelled right to forbid or withhold what is being consented to, it always is a voluntary and conscious acceptance of what is proposed to be done by another and concurred in by the former. An act of helplessness on the face of inevitable compulsions is not consent in law. More so, it is not necessary that there should be actual use of force. A threat or use of force is sufficient.

The concept of 'Consent' in the context of Section 375 IPC has to be understood differently, keeping in mind the provision of Section 90 IPC, according to which a consent given under fear / coercion or misconception / mistake of fact is not a consent at all. Scheme of Section 90 IPC is couched in negative terminology. Consent is different from submission. [Vide Uday Vs. State of Karnataka AIR 2003 SC 1639; Deelip Singh @ Dilip Kumar Vs. State of Bihar]

Benu Kumar Ghose Petitioner

Point of Law: -PENAL CODE, 1860-Secs. 406 and 420- Cognizance of offences under - Quashing of - Neither the complaint petition nor any of the circumstances indicate existence of the dishonest intention of the part of the petitioner either at the time of execution of agreement or thereafter- Dispute between the parties relates to allegation of breach of contractual obligation under the agreement to sale- Existence of dishonest intention of one of the essential ingredients of offence of cheating punishable under Sec. 420 IPC as well as misappropriation of cheating punishable under Sec. 406, IPC - No offence under Sec. 420 IPC can be said to have been made out- Proceeding quashed.

Neither the complaint petition nor any of the circumstances narrated above indicate existence of the dishonest intention on the part of the petitioner either at the time of execution of agreement or thereafter. There is absolutely no doubt that the dispute between the parties relates to allegation of breach of contractual obligation under the agreement to sale dated 19-4-2004. Existence of dishonest intention is one of the essential ingredients of offence of cheating punishable under Section 420 IPC as well as misappropriation punishable under Section 406, IPC. It has been reiterated in V.Y. Jose & Anr. (Supra) that for the purpose of constituting an offence of cheating, the complainants required to show that the accused had fraudulent or dishonest intention at the time of making promise or representation. Even in a case where allegations are made in regard to failure on the part of the accused to keep his promise, in absence of culpable intention at the time of making initial promise being absent, no offence under Section 420 of the IPC can be said to have been made out.

It is well settled that where the allegations made in the first information report or the complaint, even if they are taken at their face value and accepted in their entirety do not prima facie constitute any offence or made out a case against the accused. High Court can exercise inherent power under Section 482 Cr.PC in order to prevent abuse of the process of Court or otherwise to secure the ends of justice for quashing the criminal proceeding. A matter which essentially involves dispute of a civil nature should not be allowed to be the subject matter of criminal offence, the latter being not a shortcut of executing a decree which is non-existent. The superior Court with a view to maintain purity in the administration of justice, should not allow abuse of the process of Court. They have a duty in terms of Section 483 of the Cr.PC to supervise the functioning of the Trial Courts. Placing reliance upon the decision in Mahindra & Mahindra Financial Services Ltd. And another v. Rajib Dubey, 2006 (Supp.I) O.I.R 240 this court has pointed out in Lilasons Breweries Limited & another (Supp.I) that in the absence of any material on record or even any allegation to the effect that the accused persons fraudulently or dishonestly deceived or dishonestly misappropriated or converted to their own use or used, or disposed of any amount, the order of taking cognizance was found to have passed without application of mind. Continuance of the proceeding on the basis of such order was, therefore, held to be an abuse of process of Court.

(4) Enforcement Branch, West Bengal: -

1. On 12.07.2011 in between 16.50 hrs & 17.35 hrs. a joint search and raid was conducted by the officer and force of EB, WB being assisted by Howrah PS at 3, Jolapara Masjid Lane, Howrah and seized a huge number of spurious MANISH worth of Rs.15 Lakhs (approx.). One person was arrested.

This refers to Howrah PS Case No. 244/11 dt.12.07.2011 u/s 63/65 Copy Right Act read with Sec. 420 IPC which has been registered on the written complaint of the authorized representative of M/S Jyoti Dhaga owner user of band of 'MANISH'.

2. Acting on a secret information on 14.07.2011 a team of officers & men of EB, WB accompanied by the authorized representatives of Always Detective Service Pvt. Ltd. and officers & men of Bally PS, held a raid in the house of Sambhu Ghosh, s/o Lt. Rasik Ghosh of Surya Sen Colony, PS Bally, Howrah. During search a huge number of spurious TATA Tea and Brooke Bond Tea pouch packet of different size and weight with loose tea and sealing machine were seized.

This refers to Bally PS Case No. 468/11 dt.14.07.2011 u/s 63/65 Copy Right Act, 1957 read with Sec. 420 IPC was started. The value of seized articles was worth of Rs.2,00,00/- (approx.).

3. Acting on a secret information on 25.07.2011 a team of officers & men of EB, WB accompanied by the authorized representatives of M/S Always Detective Service Pvt. Ltd. conducted a raid & search operation at 12, Mothertala Lane, PS Golabari, Dist. - Howrah. During search a huge quantity of spurious Deodorant / perfume of different brands i.e. New AXE, AXE PLUS, Dor Silk Dry, Brut, Park Avenue, Cinthol with one sealing machine and two heating machine and some cell phone paper

sheets were seized. The value of seized articles was worth of Rs.11,00,000/- (approx.). One person was arrested. On the basis of written complaint from the authorized representatives of Always Detective Service Pvt. Ltd., Jodhpur Garden, Kolkata - 45, a case refer to Golabari PS Case No. 415/11 dt.25.07.2011 u/s 63/65 Copy Right Act was registered.

(5) Interesting detections by CID, West Bengal :-

1) Baruipur PS Case No 699/11 Dt 17.7.2011 U/S 366/363A IPC

On 27.7.11 leading to the statement of the arrested accused Iran AliMollah S/O Pear Ali Mollah of Bhotia Mollaha para,PS Canning Officers of Baruipur PS recovered one victim girl D/O Mani Laskar of Majharhat PS Baruipur from Old Delhi area.

The same team also recovered one missing woman of Dakshin Sita kundi from GB Road area The woman was missing vide Baruipur PS GDE No273 Dt 14.5.2011 and had informed of her location to her home on the basis of which the recovery was made.

2) Chanditola PS Case No 162 Dt 23.7.2011u/s 363/365/368 IPC

Over the incident of missing of two women both of Chanditola and subsequent registration of a case of kidnapping Chanditola Police arrested two women Anjana Bibi @Dutta W/O Abu Kalam and Basanti Boral w/o Lt Ranjit Boral of Dankuni & leading to their confessional statement rescued two women from Chandrani Layout, Bangalore, where both these women were taken by one Allaudin of Murshidabad with the help of the arrested accused persons.

3) Canning PS Case No. 81/11 dt. 23/02/2011 u/s 363/366A IPC was assumed by AHTU, CID. A team of AHTU went to Mumbai with a view to recover a victim and raided brothels in Budhwarpet, Pune city after getting source information that the VG was in Disco building in Pune city. But the recovery of VG could not be secured. However, the following accused was shown arrest in this case and taken to police remand. He was shown arrested from Baruipur PS Case No. 699 dated 17/07/2011 u/s 363/366A IPC. Accused Iran Ali Molla S/O Piyar Ali Molla of Volya Mollapara, PS Canning, Dist. South 24 Prgs was arrested by AHTU Cell on 03/08/2011

4) Raidighi PS Case No. 16/11 dated 31/01/2011 u/s 363/366A/34 IPC was assumed by POWC cell. A team lead by O/C AHTU with IO of the case went to Mumbai on 13/8/2011 and recovered and rescued a victim girl of Bakultala, PS Raidighi, Dist. South 24 Prgs on 16/08/2011 after identified her in a shelter home run by a NGO. Prior to that a detailed search was done in respect of victim in out state's shelter home. The victim girl rescued and produced before the Ld. A.C.J.M, Shibaji Nagar, Pune, Maharashtra with prayer for 7 days transit and produced before Ld. A.C.J.M, Diamond Harbour, South 24 Prgs.

5) Hingalgunj PS Case No. 169/08 dated 07/12/08 u/s 363/366 IPC

A team from AHTU further rushed to Khurja, dehat in Bulandsahar, UP on 21/8/2011 in c/w Hingalgunj PS Case No. 169/08 dated 07/12/08 u/s 363/366 IPC along with the principle accused Yagraj Singh @ Rokraj S/O Hemraj Singh of Village Hazratpur, PS Khurja Dehat, Dist. Bulandsahar, Uttarpradesh who was arrested on 16/08/2011and brought to West Bengal and taken into police remand from Basirhat court. After reaching Khurja the AHTU team searched the probable place as shown by principle accused and seized some bones seems to be of human being. This bone could.be of victim girl who is reportedly murdered by the principle accused. The accused arrested on 16/08/2011 from Hazratpur, Khurja Dehat, Bulandsahar, UP with a prayer for 7 (Seven) days transit remand before Ld. A.C.J.M, Bulandsahar to produce before Ld. A.C.J.M, Basirhat. The Ld. A.C.J.M, Bulandsahar was pleased for granting 4 days transit remand and produced the arrested accused before Ld. A.C.J.M, Basirhat by 20/08/2011.

6) Mahishadal PS Case No. 170 dated 22-6-2011 u/s 363/365/366/366A/366B/372/373/34 IPC and Section 3/4/5/6/7/9 ITP Act was further taken up in a view to arrest the following accused. Lakshmi Kanta Maity S/O Lt. Jnada Charan Maity of Chakdariberia, PS Mahishadal, Dist. Purba Medinipur. He was shown arrested in this case on 30/08/2011. He was arrested in Ramnagar PS Case No. 45 dt. 20/04/09 u/s 365/366/366A/367/372/34 IPC & 3/4/5/6/9 ITP Act

7) Anandapur PS Case No. 36/11 dt. 06/06/11 u/s 148/149/448/506/302/301/201/120B IPC & 25/27 Arms Act

Consequent upon discovery/recovery of large numbers of bones and skeletal remains/wearing apparels on 04.06.11 from a place named Daserbandh, Mallickdanga under the jurisdiction of Garbeta PS, the referred case was started at Anandapur PS on 06.06.11 based on the written complaint of Shyamal Acharya s/o Late Ajoy Acharya of vill. Raniorh PO: Sirshi PS Anandapur alleging that his father and some other persons were killed on 22.09.2002 out of Political grudge. A criminal conspiracy hatched up by the leaders and followers of CPI (M) party who killed them as named in the FIR and buried at the said place to conceal evidence. In connection with such recovery of skeletons/skulls and wearing apparel from the aforesaid place, Garbeta PS UD case no. 37/11 dated 04.06.11 was started on the information of one Paban Kumar Shaw s/o Late Bholanath Shaw of village Birsinghapur, PS- Garbeta, Paschim Medinipur. Sri Susanta Ghosh s/o Gandhi @ Chitta Ranjan Ghosh of Benachapra, PS Garbeta, District - Paschim Medinipur, Ex- Minister, Govt. of West Bengal, was arrested on 11/08/2011 in the abovenoted case.

Another accused person Biman Ghosh s/o Niranjan Ghosh of Piasala, PS Anandapur, Paschim Medinipur was arrested on 15/08/2011 in the same case.

8) Bally PS Case No. 205/11 dt. 06/05/11 u/s 302 / 34 / 120B IPC & 25 / 27 / 35 Arms Act

On 06.05.11 at 23;35 hrs. Shri Bablu Prasad s/o Jamuna Prasad of Purba Sapuipara, Shrabani Ashram (Kali Mondir Goli) PS-Bally, Dist. Howrah submitted a written complainant to the effect that on 06.05.11 at about 21:45 hrs. being a pillion rider of the Motor Cycle (Bearing Registration No. WB-12X-6370) driven by one Tapan Dutta s/o Lt. Karnadhar Dutta of Sapuipara, West Santinagar, PS-Bally, Howrah (deceased) were returning to their respective residences from Bally PS after submitting petition for permission regarding a convention of their Citizen Rights & Protection Forum. As soon as they had crossed the drop gate No. 1/ ½ of Bally Rly. label crossing near Bally Banga Sishu School of Ghoshpara beside the Rly. track adjacent pond, they were intercepted by 5/6 unknown miscreants who all on a sudden opened burst fire from their fire arms aiming said Tapan Dutta. As a result said Tapan Dutta sustained several bullet injuries on his persons and he felt down from his motor cycle on the road and succumbed to his injuries at the spot. The pillion rider i.e. the complt. seeing that jumped out from the motor cycle and ran away towards Palpara side for survival. The miscreants left the spot towards west i.e. State Bank Side after confirming the death of said Tapan Dutta. Over that incident on the basis of written complt. of said Bablu Prasad the instant case was started and S.I Chanchal Nandi I.O of the case. Control of investigation assumed by CID, W.B and detailing S.I Sandip Ganguly I.O of the case under the guidance of Inspector A.S.Pahari. Sasthi Gayen s/o Lt Gopal Ch. Gayen of Thakurani Chak Samabaypally ,PS Bally , Howrah and Asit Gayen s/o Lt Gopal Ch. Gayen of Thakurani Chak Samabaypally ,PS Bally , Howrah were arrested in c/w the said case by the officers of Homicide Squad on 23/08/2011.

9) Tarakeshwar PS Case No 127 dated 10/07/2011 u/s 420 / 406 IPC

One Himadri Chakroborty and his younger brother Niladri Chakroborty both S/O Ashok Chakroborty of Vill- Baidyapur PS- Tarakeshwar, Hooghly, came to the house of the complainant, Goutam Sarnakar, and convinced him to pay RS 1 lakh in order to gat a job in the Indian Railways. The complainant refused to pay the said amount. The accused persons then convinced to pay Rs 40,000/- initially and then to pay the remaining after getting the job. Accordingly, the complainant paid Rs. 40,000/- in two instalments to both the accused persons. In the mean time the accused persons showed an appointment letter of Railway department of Group C on 03.07.2011 gave him the appointntment letter and told him to join on 04.07.2011 at Bandel Railway Station. Accordingly the complainant was preparing to join on 04.07.2011 but the accused persons told him not to join until their further information. On 05.07.2011 the complainant detected that both the accused persons had fled away keeping their house under lock and key. Over this the instant case was lodged.

The said accused Himadri Chakroborty s/o Ashok CHakroborty of Baidyapur, PS- Tarakeswar, Hooghly was arrested on 20/08/2011 and Niladri Chakroborty s/o Ashok Chakroborty of do was arrested on 25/08/2011 at Gandhi Colony, Narkeldanga on 25/08/2011 by the officers of EOW Section in c/w the above noted case.

10) Serampore PS Case No 97/10 dated 06/04/10 u/s 66A/ 66B / 67 I.T. Act

Satadal Goswami s/o Basudev Goswami of Pandua Station Road, PS Pandua, Hooghly was arrested by the CID officers on 19/08/2011 in c/w Serampore PS Case No 97/10 dated 06/04/10 u/s 66A/ 66B / 67 I.T. Act .

11. On 23/06/2011 one missing girl of Buincha Durlavpara PS- Santipur, (Near Fulia out Post) Dist- Nadia was reportedly missing from her house. Accordingly MPB, CID, File No 57-2011/2/F(10) dated 25/07/2011 was opened followed by Santipur PS missing Diary No 1769 dated 23/07/2011. Oon the basis of message under National Circulate Originated by O/C MPB, CID, Circle Officer of Meerut City recovered the girl from a brothel of Brahampuri Meerut. SI Rudrajit Guha along with a team from CID, West Bengal, mother of victim girl went to Meerut. Lastly the victim girl who was in safe custody in c/w Brahampuri A.H.T.U. case no 4/11 dated 19/07/2011 u/s 3/4/5/6/7 ITP Act. was taken or bond for transmit to West Bengal. She had been brought to WB and handed over to her mother after filling up "R" form of MCTP.

12) On 26/07/2011 one Debjani Banerjee D/o Naren Banerjee was reported to be missing from 31/C, N.C. Chowdhury Road, Kol-42, PS- Kasba. Accordingly MPB File No 57-2011/1/F/(71) dated 01/08/2011 was opened flowed by Kasba PS GDE No 1817 Dated 26/07/2011. All informative actions, i.e. broadcasting through AIR, telecasting through Television and publication of the photograph in leading Newspaper through Director Information and Cultural Affairs was done.

On 06/08/2011, one unknown person informed that Debjani Banerjee, missing girl was seen at Jaynagar PS. area. Accordingly with the help of Local PS the Missing girl was recovered from Joynagar South 24 parganas.

13) On 25/07/2011 one Jharna Ghosh W/o Swapn Ghosh of Danguajhar, Tea Garden Staff Qtr., PS Kotowali, Dist- Jalpaigury left her house after a hot altercation with her husband. Accordingly MPB, File No 57-2011/13/F(2) dated 11/08/2011 was opened followed by Kotowali PS GDE NO 704 dated 26/07/2011. All informative actions i.e. telecasting through television, broadcasting through AIR, Publication in leading newspaper through the Director Information and Cultural Affairs was done. Leaflet was also distributed in the leading Railway Stations in the North Eastern and Eastern Railway division. On 17/08/2011, one tea stall owner from Katwa Railway Station informed over telephone that the missing lady was residing in Ananda Niketan, one NGO maintained Home, near Katwa Mental Health Care. Atlast on 19/08/2011, Bapi Ghosh, brother of the missing person went to the Home and traced the missing lady.
