23) On 06/08/08 one Steel Colour Hero Honda (Ambition) Motor cycle No. WB-64B/3553, Engine No. 04H60M06918 and Ch. No. 04H63C06717 was seized as unclaimed from Bhabani Ganj Bazar PS Kotwali District Cooch Behar in abandoned condition. This refers to Kotwali PS GDE No. 422 dt 06/08/08.

24) On 06/08/08 one red colour Bajaj (Kwashaki Wind-125) Motor cycle No. WB-70A/0053, Engine No. DDM-BKC-003450 and Ch. No. DPE-BKC-00225 was seized as suspicious property from Tufanganj PS area, Cooch Behar. This refers to Tufanganj PS GDE No. 278 dt 06/08/08.

(D)(i) Property lost, stolen or seized on suspicion.

(1) On 29/7/08 around Harirampur PS. Police recovered One licensed Gun of One Joynal Abidin of Benail PS. Harirampur at Karanjabari in a field. This Refers to Harirampur PS. Case No-85 dt.29/7/08.u/s.380.IPC.

(2) On 2/8/08 around 20:30 hrs 6/7 dacoit (25/30) being armed with small arms and musket entered into the house of One Nasim Ahmed of Majlispur Mahallah Jhantibari and snatched away one Licensed D.B.B.L Gun bearing No-8601 made by Das & Company, having License No-559/99 including 15, rounds of .12 bore ammunitions, Cash RS-45,000/- and some gold Ornaments after opening the almirah on the Point of Fire-arms. The dacoits also Caught one neighbour Munna @ Hassan Yunus and tied him with rope to Keep Silence. They also entered into the house of One Jiaur Rahaman and took away some

article and they hurled bombs while leaving the place and also opened fire in air from their Fire-arms. This refers to Goalpokhar PS. Case no-125.dt.3/8/08.u/s395.IPC.

(D)(ii) Arms and ammunition – loss, stolen and recovery

- (1) On 10-11/7/08 night, a theft was committed by some unknown miscreants in respect of cash Rs 2.06 Lacs and some gold ornaments from the house of one Prasenjit Ghosh of P-II, Apollo Acvenue Bidhan Nagar after breaking the maindoor of the house. This refers to New Township PS c/no 49 dt 12/7/08 u/s 380 IPC.
- (2) On 11/7/08 around 23:00 hrs while one Chandradeo Thakur, driver of oil tanker no WB-11A/2531 along with his helper reached Garughata PS Mahisadal (On NH-41) after loading petroleum product from I.O.C. At that time 6 unknown miscreants being armed with deadly weapons stepped inside the tanker and over powering the driver tied him and his helper and covered their faces and also hijacked the said loaded tanker keeping them at a lonely place. On 12/7/08 around 9:30 hrs the miscreants threw them near H P Petrol Pump, Debra. This refers to Mahisadal PS c/no 75 dt 13/7/08 u/s 395 IPC.
- (3) On 14/7/08 Neturia PS police seized one stolen Mini Truck No WRH/131 loaded with 1.5 M.T. (approx) Iron Scrap. This refers to Neturia, Purulia PS c/no 29 dt 14/7/08 u/s 414 IPC.
- (4) On 11-12/7/08 night a theft was committed by some unknown miscreants in respect of cash Rs 50,000/-, some gold ornaments and one Voda Mobile Phone etc from the house of one Adhir Barman of Purba Jagadanandapur Madhyapara. This refers to Nakashipara PS c/no 250 dt 12/7/08 u/s 380 IPC.
- (5) On 9-10/7/08 night a theft was committed in respect of Idol of Brass made “Radha” and “Gopal” from Pathakpara Temple by some unknown miscreants. This refers to Bankura PS c/no 147 dt 16/7/08 u/s 380 IPC.
- (6) On 14-15/7/08 night, a theft was committed by some unknown miscreants in respect of one Brass made Idol of Goddess “Radha Krishna” and 4 pcs of brass made Idols of Lord “Gopal from Sree Dwarikanath Dev Tapashyi Mandir. This refers to Mayureswar PS c/no 78 dt 16/7/08 u/s 379 IPC.
- (7) On 15/7/08 around 11:26 hrs a theft was committed by some unknown miscreants in respect of one Black colour Leather bag containing cash Rs 1,25,000/- from one Nandalal Balti (40) of Kumargarh PS Chanditala Dist – Hooghly while he was traveling by DN Burdwan – Howrah local train. This refers to Kamarkunda GRPS c/no 10 dt 17/7/08 u/s 379 IPC.
- (8) On 17-18/7/08 night, a theft was committed by some unknown miscreants in respect of gold & silver ornaments, idol of Laxmi & Jagadhatri etc from Bakshi Kali Mata Temple after breaking the ventilator. This refers to Purulia (T) PS c/no 95 dt 18/7/08 u/s 461/379 IPC.
- (9) On 17/7/08 around 4:40 hrs one Sasanka Das of Dubrajpur Lalbazar Word No – 2 left his house to avail Kolkata bound Bus from Power Hosue More, Dubrajpur with cash Rs 3,30,000/- and some documents for business purpose and while reached near Haripara Kalimandir at Dubrajpur, 2 unknown miscreants attempted to snatch his bag containing the said cash and on giving resistance, the miscreants assaulted him with fist and blows and another miscreant riding on a m/cycle appeared there and shoot on his leg and succeeded to snatch away the said bag. This refers to Dubrajpur PS c/no 85 dt 17/7/08 u/s 394 IPC & 25/27 Arms Act.

- (10) On 20-21/7/08 night, a theft was committed by some unknown miscreants in respect of some computer parts, grocery article, cash Rs 24,723/- total worth Rs 2,20,849/- (approx) from the shop of one Abhijit Modak of 37, Garia Place styled as Lila Enterprise at N S C Bose Rd, Kodalia after breaking the lock of the door. This refers to Sonerpur PS c/no 427 dt 21/7/08 u/s 380 IPC.
- (11) On 20-21/7/08 night, a theft was committed by some unknown miscreants in respect of cash Rs 1,88,500/- (approx) from Uma Carrying Corporation office after breaking the lock of the Shutter. This refers to Jaigaon PS c/no 348 dt 21/7/08 u/s 457/380 IPC.
- (12) On 21-21/7/08 night, a theft was committed by some unknown miscreants in respect of cash Rs 40,000/- and some gold ornaments from the house of one Gobinda Lal Gopi of Thherpur D/15. This refers to Taherpur PS c/no 159 dt 21/7/08 u/s 380 IPC.
- (13) On 23/7/08 around 17:30 hrs, a theft was committed by some unknown miscreants in respect of one Shivlinga made of black marble from Old Shiba Temple beside Kali Temple at 95, Jagat Banerjee Ghat. This refers to Shibpur PS c/no 271 dt 23/7/08 u/s 379 IPC.
- (14) On 24/7/08 around 12:00 hrs a theft was committed by some unknown miscreants in respect of cash Rs Rs 2,80,000/- from one Abhishek Nandi of Sntirmath PS Berhampore which was kept in his motor cycle dioky. This refers to Berhampore PS c/no 359 dt 24/7/08 u/s 379 IPC.
- (15) On 24/7/08 between 9:00 hrs and 12:00 hrs a theft was committed by some unknown miscreants in respect of cash Rs 1.5 Lacs (approx), some gold ornaments, wrist watch and camera from the hosue ofone Rakshit Kr Bera of Bani Apartment Plat No – 1 -89A Sahid Mangal Pandey Sarani. This refers to Titagarh PS c/no 236 dt 24/7/08 u/s 380 IPC.
- (16) On 28/7/08 around 20:00 hrs while one Sulekha Maity of 96/4 Fakir Chand Pathak Lane was coming from Bally UBI Branch after withdrawing cash Rs 50,000/- which was kept in a bag at that time an unknown persons took away the said bag containing the said amount on Mashab banerjee Rd. This refers to Bally PS c/no 225 dt 28/7/08 u/s 379 IPC.
- (17) On 29/7/08 early morning, a theft was committed by some unknown miscreants in respect of one VIP Suitcase containing cash Rs 95,000/-, 10 pcs of new sarees, 3 / 4 pcs of shirts and pants etc while he was traveling by Dn – 30006 Amritsar Mail. This refers to Howrah GRPS c/no 211 dt 29/7/08 u/s 379 IPC.

4. Enforcement Branch, West Bengal : -

1) In pursuance of a secret information team of E.B. officers accompanied by I.O.C. Officer held a raid on 12.6.08 in the restaurant M/S. Family Chicken, C.F.-123 Sector-1, Salt Lake Kolkata for illegal consumption of domestic LPG for commercial purpose. On the basis of complaint from sales Manager(LPG,IOC) a case has been started vide Bidhannagar P.S Case No.98/08 dt .12.6.08 u/s.7(i)(a) of E.C.Act,1955.3LPG Cylinder and 3, Regulator have been seized worth of Rs.3754/-. The Manager of Family Chicken has been arrested.

2) A similar raid was held on 12.6.08 accompanied by I.O.C. officer & E.B. officers in the restaurant styled as Misra's at DG-I, Sector-II, Salt Lake, Kolkatta-91 for use of domestic LPG in commercial purpose. In the connection Bidhannagar PS case No-68.dt.12.6.08 u/s.7(i)(a)(ii) was started 9 LPG cylinders, 6 Regulators 7 Big Ovens etc.Have been seized.The value is worth of Rs-26,470/-The Manager of the restaurant was arrested.

3) A raid was held on 12.6.08 by the E.B.Officers accompanied with I.O.C. officer in DANDIN restaurant at BE-107 Salt Lake Sector-1 for use of domestic LPG in commercial purpose. In this context a case Ref .to Bidhannagar North PS case No-96/08 dt.12.6.08 u/s.7(i)(a)(ii) Of E.C. Act was started and 2 LPG domestic cylinder & 1-Commercial Cylinder was seized. The owner of the restaurant was arrested. Value of seized commodities was RS.5,000/-.

4) A joint search operation was conducted by the E.B.officers and I.O.C. officers on 12.6.08 in the restaurant named East Treats at C.F.-124, Salt lake Kolkata the illegal consumption of domestic LPG for commercial purpose. A case ref. to Bidhannagar North PS Case No-97/08 dt.12.6.08 was started. 5-Nos. of filled LPG Cylinder, Oven and gas regulator with rubber tube and cooking utensils were seized of RS-14,300/-.The Manager was arrested.

5) A joint search operation was conducted by in E.B officers and I.O.C. Officer on 12.6.08 being assisted by local police in the Baguihati Bazar area against illegal use of subsidised domestic cooking gas for commercial purpose . During search operation 5-used empty cylinders of Indane along with delivery pipes fitted with regulators and Oven were seized from a Snax Shop of Montu Paul. A case ref. to Baguihati PS case No-157 dt.12.6.08 u/s.7(i)(a)(ii) of RS-5675/-..In this connection 1 Person has been arrested.

6) A joint search operation was held in the Sweet meat shop of one Tapan Baguli of Baguihati Bazar for illegal use of domestic cooking gas in commercial purpose. 4-LPG Cylinder (Indane),one delivery pipe fitted with regulator and one gas oven have been seized worth of RS-4852/-. In this context a case ref. to Baguihati PS case No-158 dt.12.6.08 u/s.7(i)(a)(ii)of E.C.Act,1955 was started.

7) As ordered by E.B.W.B. an officer of this branch conducted enquiry on 27.6.08 reg. illegal trading of P.D.S. K.Oil. During enquiry at 12/1/6/1 Nandalal Mukherjee Lane, Chaterjeehat PS Shibpur with the assistance of local PS 135 Ltrs. Of Blue K.Oil in

7 Jerry cans was seized from the house of Pyareilal Show. The value of seized commodities was RS-1400/-. This refers to Shibpure PS Case No-219/08 dt.27.6.08 u/s.7 (i)(a)(ii) of E.C.A.ct. was started.

5. **Interesting detections by CID, West Bengal.**

On search , the following articles were seized from their possession , total 500 pcs of FICN of denomination of Rs.100/- amounting Rs.50,000/-. This refers to Kasba PS Case No 271 dated 30/08/2008 u/s 489B/489C / 120B IPC

2.) On 08-07-08 at about 15:00 hrs. one Debasree Das (17) D/o Nikhil Das was reportedly missing from her house. Accordingly Nandigram PS Case No. 197/08 dt. 13-07-08 u/s 368/ 365/ 109 IPC was started and at the same time MPB CID File No. 54-2008/ 7/ F (3) dt. 25-07-08 was opened. All action as per Hon'ble Supreme Court guide line was taken. As per direction of IGP – I CID enquiry was made. DDI Purba Medinipur was informed and one Santu Maity and Nantu Maity was closely interrogated. Lastly as per combined input of information from DDI Purba Medinipur and MPB, CID the missing girl was recovered at Johori More under Nandigram PS.

3) Jyoti Jaiswal (16) D/o Umesh Chandra Jaiswal of 368, Rajarhat Road, Rajarhat, Argopalpur 700059 was missing since 30-07-2008. Accordingly MPB CID File No. 54-2008/ 1A/ F (55) dt. 31-07-2008 was opened. Photograph of the missing subject was circulated through 24 concerns including Doordarshan, Newspaper, Howrah GRPS, Sealdah GRPS etc. On 05-08-08 the missing girl was traced at Sealdah Station and O/C Sealdah GRPS handed her over to NGO concern, styled a SIMI at 61, R.A.K. Road (Prof. Bani Dutta) SIMI contacted with us and we in turn informed guardians of the missing subject. Thus the missing girl is recovered. It is a good work done by MPB, CID.

4) Working on source information, on 25/08/2008 SI Simul Sarkar, SI Ashim Mondal, ASI Prabirendra Bhattacharjee , W/C-946 Harendra Kumar Singh of Cheating and Fraud Section, CID,WB under leadership of Inspector Shri N.N.Bhattacharya held a raid at Rupnarayanpur under Salanpur PS, District Burdwan and recovered and seized one DBBL gun and 3 SBBC gun from the possession of 1) Bikash Chakraborty s/o Lt Ram Ramprasad Chakraborty of gobindapur PS Pandabeswar, District-Burdwan 2) Santosh Kumar (29 years) s/o Sahadeb of Nabin Nagar PS + District-Katihar 3) Navin Kumar Mishra s/o Ramashish of Maheshi, PS Sultanganj , District-Bhagalpur, Bihar and 4) Prakash Chandra Ghosh s/o Rabindranath Ghosh of Kamala Kanta Kararya, PS-Misganj, District-Gopalganj, Bihar. This refers to Asansol (S) PS Case No. 23/08 dated 21/01/2008 u/s 466/467/468/471/472/473/474/120B IPC & Sec. 25/27 Arms Act & Sec. 3/5 ES Act and added section 379/411 IPC.

5) In course of investigation of Sankrail PS Case No. 241 dated 27.09.2006 u/s 461/379 IPC one accused named Lokman Shah of Shahpara , Bakitala, PS Uluberua District-Howrah was shown arrested in connection with the above noted case and 4 mobile sets had been recovered on 19.08.2008 by SI Krishnendu Ghosh of DRBT Section.

6) On the basis of secret source information of Rly. & highway Crime Cell, in c/w Ramnagar PS (District-South 24 Parganas) Case No. 09/08 dated 30/01/2008 u/s 407/120B IPC , plastic granules valued about Rs. 4,00,000/- had been detected and recovered and the entire gang had been arrested.
