1) Ref : C.4 No. 7599-5/X/2009/c of "Q" Branch CID, Chennai-4 Dated 18.05.2009.

One EMU was whisked away by an unknown person from Chennai Central Suburban Terminal and rammed into a Goods Train at Vyasarpadi Jeeva Railway Station, Chennai on 29.04.2009, killing 4 passengers and injuring 12 persons (7 male and 5 female). Though the exact cause of the accident is under probe, it is dangerous modus operandi.

The photograph of the following person who is suspected to have whisked away the said Electric Train and the noted information sent to us by Chennai Police.

As per details / description it appears that the person hails from Andhra Pradesh and his name might be " Dhoga Raju". Since the identity of person is yet to be established by the local police. CID, West Bengal has been requested to circulate the same for wide publication and proper identification.

A Criminal Case RC SIJ 2009E0006 dated 10/06/2009 has been registered against Jalvir Pandit @ Jallu Pandit @ Sharma and his brother Srichand Pandit @ Sharma both resident of Village Pai , Tehsil- Kama, District-Bharatpur, Rajasthan u/s 120B IPC & Section 414 IPC and Section 25(2) R/W 14(3) and Section 25(2) R/W 14(3) and Section 5 of the Antiquities and Art treasure Act, 1972 following seizure of one Shiv Linga in sand stone of 47.5 length and 11.5 diameter having four sculptures on all four cardinal directions containing Shiva, Vishnu, Surya and removed head of Lord Brahmma with large number of attendance on the pedestral part. These idols are suspected to have been stolen from ancient Temples, Monuments, Archives, museums or various sites of excavation.

Since it is strongly suspected that this stone Shiv Linga might have been stolen from various places of Historical Importance and Archaeological sites in and around some places in the country falling under your jurisdiction for which some criminal cases relating to theft of these Antiquities/ Objects in stone might have been lodged in the concerned police station areas.

4. Interesting detections by CID, West Bengal - Nil.

1) On 24/7/09 around 11:30 hrs South Industrial DD staff held raid in front of Ajanta Cinema Hall, Diamond Harbour Road, and arrested one Palan Sanpui @ Bhaskar s/o Lt Raviram Sanpui of G-10, Sahid Smriti Colony, PS Purba Jadavpur and seized one improvised firearms loaded with one round .303 live cartridge from his possession. This refers to Behala PS c/no 298 dated 24/07/09 u/s 25(i)(a)/27 Arms Act.

2) CID, West Bengal Missing File No. 55-2009/6/F (11) dt. 26-06-09 was opened over the missing of one Smt. Sharita Sharma (48 Yrs.) W/o Bhanuprotap Sharma of Rabindra Pally, PO-Amarai, PS – Durgapur, Dist Hoogly. She has been missing since 03-06-2009 along with her 2 sons namely Rajdeep and Sandip Sharma and daughter Priyanka Anand Sharma from their residence.

During enquiry it revealed that the above family members were mentally tortured by her husband and was father-in-law who were indifferent and rude towards his wife and children regarding their maintenance in day to day life. In this regard all the missing persons took a plan to leave the house of Bhanu Protap Shingh and decided to settle up at Delhi/ Pune with the help of their other relatives.

MPB Section searched Tower location of the Mobile phones used by the missing candidates. The tower location came at Delhi R.S.area. It was informed to the petitioner and by dint of good effort from MPB Section. All the family members have been traced from Delhi and staying at Durgapur at present.

3) CID, West Bengal Missing File No. 55-2009/1A/M (67) dt. 09-07-09 was opened over the missing of one Aritra Roy Chowdhury (21 Yrs.) S/o Biswanath Roy Chowdhury of Bichalighata, PO +PS – Bongaon, Dist – North 24-Parganas since 07-07-09 from Bongaon College Football Ground.

During enquiry it revealed that the boy was a mentally disabled person. He had in the habit of cycle riding. In this regard a thorough search was done at Chakda, Gangnapur, Ranaghat & Habra PS area. Subsequently on the basis of an information received from Ranaghat Station. However CID Missing Section contacted with O/C Naihati GRPS, Barrackpur GRPS, Sealdah GRPS when it was noticed that the said boy was at an Dn Gade Local

Later the boy was recovered from Sreerampur PS area. MPB Section contacted with the family members of the missing boy and the boy has been handed over to his parents. This is obviously a good work on the part of MPB Section.
