Special Notice:

Order of Sri K. C. Verma, Director General, Narcotics Control Bureau, West Block, Wing – 5, R. K. Puram, New Delhi – 110066, under his DO F-NoVII/17/2005-Int Dated 02/02/2006 is reproduced below regarding disposal of seized Narcotic Drug and Psychotropic Substances:-

Enforcement activities against drug traffickers in the country have been a continuing process. As a result, huge quantities of drugs and psychotropic substances have been seized by enforcement agencies, including state police authorities from time to time.

2. While reviewing the progress of the disposal of seized / confiscated narcotic drugs and psychotropic substances by some of state police authorities, it has been observed that huge quantities of seized narcotics drugs and psychotropic substances have accumulated in many places.

3. You will appreciate that non-disposal of seized/confiscated drugs for long periods of time because of different factors (including pendency of court cases) is highly undesirable. The accumulation of banned substances chokes the 'malkhanas' in police stations and poses a health hazard at some places. Such accumulation also makes the police vulnerable to accusations of theft, substitution and substance abuse.

4. Keeping these aspects in view, the NDPS Act, 1985, was amended in 1989 with the insertion of Section 52 A. Having regard to the hazardous nature, vulnerability to theft, substitution and constraint of storage space, Government of India specified narcotic drugs and psychotropic substances vide notification No. 4/89 dated 29.5.1989, enabling the enforcement agencies to dispose off the seized narcotic drugs and psychotropic substances (including before trial) after following the procedure prescribed under Section 52 A (2).

5. A copy of the aforesaid Notification No. 4/89 dated 25.9.89 as well as Standing Order No. 1/89 dated 13th June, 1989, have been sent to the office which provides for receipt, storage, pre-trial disposal and constitution and functions of drug disposal committee, etc. You may like to bring the contents of these to the notice of the officers under you for immediate necessary action)

6. I shall be grateful, if you could kindly look into the matter personally and review the progress of disposal of seized/confiscated narcotic drugs - and psychotropic substances in your state periodically and intimate this Bureau the drug-wise total stock of drugs and psychotropic substances lying in various godowns/malkhanas under your control as on 31.12.2005.

It is also requested that the Monthly Master Report from your Narcotic Cell/Wing may be sent regularly to the NCB so that inputs by us are received in a timely manner.

All SPs/SRPs are requested to send report regularly to DIG (Spl), CID, WB by 1st week of every month for onward transmission to Narcotics Control Bureau, New Delhi, after compilation of the same by DS (Narcotics Cell), CID, West Bengal.

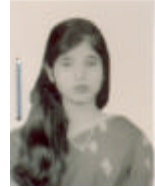

(4) Interesting detections by CID, West Bengal.

1. On 16/2/06 in between 14:50 hrs to 15:30 hrs acting on source information a team of officers of Barrackpore DD with the help of Khardah PS Police arrested one Madhusudan Mukherjee @ Madhu @ Adhikary s/o Lt Bhim Mukherjee of Uma Charan Chatterjee Bye Lane, Panihati, PS Khardah, District North 24-Pgs and recovered one rexine bag containing 2 kgs of Ganja in a polythene packet and one stain bearing Arsonal No A-07493 having firing pin, butt, trigger etc and also engraved in English at the near Porffito Barrels Estate Property of China Govt .18 rounds sub carbine made in China only Army supply 1925 along with 2 empty magazine of sten gun and along with 2 empty magazine of sten gun and a Nokia 6020 phone from his possession. Barrackpore DD is investigating the case. This refers to Barrackpore PS c/no 46 dt 16/2/06 u/s 20(B) NDPS Act & 25/27 Arms Act.

2. DDI Barrackpore DD, CID West Bengal alongwith staff held a raid in the house of PC accused Madhusudan Mukherjee @ Adhikary @ Madhu @ Tapas Banerjee s/o Lt Bhim Mukherjee of Umacharan Chatterjee by Lane, PS-Khardah, District-North 24 Pargana in c/w Khardah PS Case No. 46 dated 16.02.06 u/s 20(b) NDPS Act and u/s 25/27 Arms Act and recovered 5(five) pieces of improvised fire arms and 10 pcs of live ammunitions from the dump of garbage beneath the staircase of his house . The arms and ammunitions were kept inside a synthetic coloured bag. Previously a sophisticated arms was recovered from his possession. This refers to Khardah PS Case No. 52 dated 19.02.2006 u/s 25/27 Arms Act.

3. This is a cheating case where a group of criminals amassed a huge amount of money to the tune of Rs.1 Crore from a few hundreds of people of different districts like Nadia, Hooghly, Murshidabad etc. alluring them of giving jobs of teachers in Government Primary Schools. The instant case was started on the basis of one Md. Sarifuddin Biswas of Gourpota, PS-Hanskhali, Nadia. Primary investigation has so far revealed that one Mannan Ali, of Mamudpur, PS-Domkal, Murshidabad along with Samir Banerjee of Chinsurah of Chinsurah, hooghly, Alope Bose of Khanyan, Hooghly, Shelly Mondal of Champdani, Hooghly, Biswanath Ghosh of Memari,

Burdwan, Obaidul Haque of Mamudpur, Domkal, Murshidabad and some others are involved in this case. They formed an organization entitled “ Primary Teachers Organizers Association” and forged different documents as well as signatures of Hon’ble C M, Education Minister, Finance Minister of West Bengal and of some high officials of the Education Department. On 07/02/2006 Obaidul Haque one of the main accused persons has been arrested from Domkal, Murshidabad. He is on Police remand till 17/02/2006. Earlier Samir Banerjee and Ehsan Ali Mondal have been arrested. This refers to Chinsura PS Case No. 280/05 dt 07.10.05 u/s 420/406/120B IPC.

4. On the basis of information received from one of the rescued girls from Mumbai prostitution area, CID WB held raids in Joynagar and Sonarpur areas of South 24-Pgs district and arrested Asit Naskar @ Bablu, Shalem Naskar, Golam Sardar, Soma Halder, Mona Laskar, Mithu Naskar who are involved in the activity of trafficking.

5 On 30/01/2006 in pursuance of a secret information DDI Hooghly, Inspector Sri Ajoy Sinha of CID West Bengal and other police personnel arrested 1. Raju Halder s/o Ganesh Halder of Sibrambati, PS-Singur, Hooghly and 2. Sattya Koley @ Swapan s/o Jogesswar Koley of Chinamore, PS-Do and seized 2 Maruti Omni white coloured vans bearing nos. DNH-2769 and WB-16H/1625 converted from DNH-8517 without any paper from their possession. This refers to Singur PS Case No. 09 dt 30.01.2006 u/s 413/414 IPC.

6. CID officers held raid against the Fake Indian Currency Note dealers and arrested four persons named 1. Shanti Ranjan Biswas 2. Tushar Mondal both of Kaijuri, PS- Swarupnagar and 3. Rabin Mondal 4. Mongal Mondal of Peali, PS-Canning. So far Rs.15000/- Fake Currencies have been recovered. Shanti Ranjan used to collect Fake currencies from a Bangla Desh national in the border area by paying 50% genuine currency. They had made transactions on earlier occasions also. This refers to Canning PS Case No. 25 dt 31.01.2005 u/s 489A/489B/489C/120B IPC.

7. Eight girls aged 16 to 22, along with an eight month old child have been rescued from various brothels of Mumbai, by CID Women Grievance Cell officers. The victim girls from Habra, Barasat, Ashoke Nagar, Kashba, Joynagar, and Canning areas, had been sold off to traffickers in Mumbai after being lured, by touts, in the name of employment. Some touts have already been identified.

(5) Enforcement Branch, West Bengal :

1. Chhatna PS c/no 3 dt 25/1/06 u/s 7-X-55 started against one Prasanta Musib, owner of “M/S Arabinda Machineries” of Jhantipahari, PS Chhatna, District Bankura, 179.5 ltrs of Engine Oil were seized. The value of the seized articles worth Rs. 20,000/-.
