(A) Persons wanted.

1. One Raj Kumar Basu s/o Bishnupada Basu of 46, Hrishikesh Chattarjee Lane, Burdwan lodged a written complaint at Burdwan PS against one Binode Gupta, a Rickshaw puller to the effect that he murdered his wife on the night of 2/3/04 in his rented house at J B Mitra Lane, PS and District Burdwan. Some gang members with these trucks are still at large. It is reliably learnt that some of the absconding accused may still use these vehicles for committing similar dacoities in any part of the country.
