- ii) On 13/05/2009 around 09:15 hrs , 6 unknown miscreants looted away cash Rs. 3,30,000/-, one motor cycle no. WB34M-5118 and 2 pcs of mobile phones on Kharikamathani to Bhasraghat Pucca Road from some businessmen who was

- iii) coming to Kharikamathani Hat to purchase cows. This refers to Nayagram PS Case No. 21 dated 13/05/2009 u/s 395 IPC.
- iv) On 15/05/2009 a theft was committed by some unknown miscreants in respect of cash Rs. 95,000/- from Sub-Divisional Information & Cultural Office Almirah, Kurseong. This refers to Kurseong PS Case No. 61 dated 15/05/2009 u/s 380 IPC.
- v) On 15/05/2009 around 04:30 hrs., a theft was committed by 3 unknown miscreants in respect of cash Rs. 85,000/- , cash cards, SIM cards and new connection forms etc. of Airtel from the Mobile Shop of one Arindam Pal of B-4/61 , PS-Kalyani . This refers to Kalyani PS Case No. 226 dated 15/05/2009 u/s 379 IPC.
- vi) On 14-15/05/2009 between 22:30 hrs and 06:00 hrs , a theft was committed by some unknown miscreants in respect of some grocery articles and cash total amount Rs. 3,26,009/- (approx) from the grocery shop of one Prabhat Chandra Mallick styled as “ Prabhat Stores” at Kanki Busstand after breaking open the shutter of the shop. This refers to Chakulia PS Case No. 58 dated 15/05/2009 u/s 461/379 IPC.
- vii) On 18/05/2009 one Sudhir Chandra Mahato of Chirugora, PS-Kotshila , District-Purulia, along with Akhilesh Singh, Fore-Man of Jabar Mines went to Jabar by a motor cycle with cash Rs. 76265/- for labour and staff payment. Around 13:45 hrs while they reached near Bara –Hankal village when 2 unknown miscreants riding on a Black coloured Hero Honda Motor Cycle intercepted them and snatched away the entire cash from their possession at the point of fire arms. This refers to Kotshila PS Case No. 17 dated 18/05/2009 u/s 392 IPC & 25/27 Arms Act.
- viii) On 17/05/2009 around 22:05 hrs 2/3 unknown miscreants robbed away cash Rs. 89,574/-, 2 gold rings and 2 Nokia Mobile phones from one Subhendu Kumar Roy of Bhaduria at Bhaduria near Milan Mandirpara. This refers to Swarupnagar PS Case No. 148 dated 18/05/2009 u/s 394 IPC.
- ix) On 19/05/2009 around 14:15 hrs , 4 unknown miscreants restrained one vehicle No. WB-37A/9528 on NSB Road near Poddar Traders and snatched away one bag containing cash Rs.2,39,500/-, 2 mobile phones and some documents from one Purnendu Bhandari of New Egra, PS-Raniganj and fled away. This refers to Pandabeswar PS Case No. 30 dated 19/05/2009 u/s 392 IPC.
- x) On 21/05/2009 round 11:30 hrs while one Rajesh Mondal, cashir of Ujjivan Financial Service Pvt. Limited, Tribeni along with one Debapriya Ghosh were proceeding towards their Branch Office at Mogra Adhikaripara after withdrawing cash Rs. 4,18,000/- from Axis Bank , Chinsurah Branch in an Auto when one Maruti Car No. WB-02/1681 intercepted the Auto near Mithapukur on Assam Road and some unknown miscreants got down from that Mauti car and snatched away the entire cash from their possession. This refers to Mogra PS Case No. 79 dated 21/05/2009 u/s 392 IPC.
- xi) On 21/05/2009 around 11:00 hrs a theft was committed by some unknown miscreants in respect of Cash Rs.1,00,000/ - from one Prabir Mondal of Abira. This refers to Pandua PS Case No. 97 dated 21/05/2009 u/s 379 IPC.

- xii) On 23/05/2009 around 20:45 hrs 2 unknown miscreants committed theft in respect of cash Rs.1,00,000/- from the bag of one Jagat Bandhu Dhali of 788/2, Mehendra Banerjee Road, near Padma Pukur, Milan Samity. This refers to Behala PS Case No, 214 dated 23/05/2009 u/s 379 IPC.
- xiii) On 16/05/2009 around 20:30 hrs 4 unknown miscreants assaulted Sunil Kumar of 85, Jagannathpur Transport Nagar and two other boarders of Tankar and also forcibly compelled them to consume some intoxicants for causing their drowsiness and senselessness. Later, on 19/05/2009 they regained their sense and they found that they were lying beside NH-60 near Niramoy Morh under PS-Dubrajpur and realized that their Tanker with goods had already been robbed away. This refers to Dubrajpur PS Case No. 72 dated 23/05/2009 u/s 392 IPC.
- xiv) On 22/5/09 around 17:30 hrs., Cash Van of UCO Bank, Dhupguri Branch with Cash Rs. 1,24,50,000/- with a vehicle which was driven by Sri Amar Lama, escorted by Armed guard Sri Dharendra Nath Roy, Watchman Sri Gopal Basak and Cashier Sri Jogendra Nath Roy. On the way after Crossing Maynaguri Road near the Petrol Pump a group of dacoits (10) boarded a DI Pick-up Van stopped the said Cash Van and at the point of gun after assaulting the Bank Staff/driver and pushing away them from the vehicle and they drove away the Cash Van through Marichbari Road towards Domohoni with the Armed guard of the Cash Van. They threw out the Armed Guard after crossing the Rail Gate of Domohoni and they also took away Bank Arms .12 Bore DBBL Gun with 10 rounds of cartridges. This refers to Maynaguri PS Case No. 128 dated 22/08/2009 u/s 395 IPC.
- xv) On 23/05/2009 around 14:30 hrs , 3 unknown miscreants committed theft in respect of cash Rs.1,00,000/- from the hand bag of one Rajesh Kumar Gupta of RN Sinha Road. This refers to Sadar PS Case No. 48 dated 23/05/2009 u/s 379 IPC.
- xvi) On 22/5/09 around 14:00 hrs., a theft was committed by some unknown miscreants in respect of cash Rs. 1,00,000/- from the Tool Box of M/Cycle of one Emdadul Haque of Nashipur Balagachi which was parked at Lalu Sk.'s M/Cycle Garage near Amaipara Petrol Pump. This refers to Jiaganj PS c/no 78 dt 22/5/09 u/s 379 IPC.
- xvii) On 24/5/09 around 13:45 hrs., 3 unknown miscreants looted away cash Rs. 6,20,000/- and 2 Pcs. of Mobile sets from Swagat Retail Outlet at Hogalberia, IOCL Petrol works beside NH-41 at the point of fire arms. This refers to Tamluk PS c/no 164 dt 24/5/09 u/s 395 IPC.
- xviii) On 23/5/09, a theft was committed by some unknown miscreants in respect of an Image of Goddess Durga valued Rs. 35,000/-, cash Rs. 15,000/- and some ornaments valued Rs.28,000/- (approx) etc. from the house of one Barun Kr. Mishra of 28, Ghoshpara Road, Shyamnagar. This refers to Jagaddal PS c/no 223 dt 25/5/09 u/s 380 IPC.

- xix) On 25/5/09 between 12:30 hrs. and 13:00 hrs., a theft was committed by some unknown miscreants in respect of cash Rs. 3,00,000/- and 9 bhories of gold ornaments from the house of one Anil Basak of Millpara, Ward No.4 after breaking the lock of the door and Almirah. This refers to Dhupguri PS c/no 100 dt 26/5/09 u/s 454/380 IPC.
- xx) On 27/5/09 around 12:00 hrs., a theft was committed by some unknown miscreants in respect of cash Rs. 4,00,000/- (Four Lacs) from one Mrinal Kanti Guin, BDO, Balurghat. This refers to Balurghat PS c/no 155 dt 27/5/09 u/s 379 IPC.
- xxi) On 28.29/5/09 night, a theft was committed by some unknown miscreants in respect of cash Rs. 42,33,070/- and huge numbers of Nokia Mobile sets worth Rs. 9,47,670/- (approx) from the shop of one Ashis Banshal of "Sanat Trade Centre", Sevoke Road. This refers to Siliguri PS c/no 215 dt 29/5/09 u/s 461/379 IPC.
- xxii) On 29/5/09 night, a theft was committed by some unknown miscreants in respect of cash Rs. 1,10,000/- from the shop of one Joydeep Kumar Khaitan of 522, D.H. Road. This refers to Behala PS c/no 222 dt 30/5/09 u/s 379 IPC.
- xxiii) On 29/5/09 between 20:00 hrs. and 20:30 hrs., 4/5 unknown miscreants committed dacoity in respect of cash Rs. 1,00,000/- (approx) from the Rice Shop of one Dulal Chakraborty of Ward No. 12. This refers to Dhupguri PS c/no 103 dt 29/5/09 u/s 395 IPC.
- xxiv) On 29/5/09 around 14:45 hrs., while one Sajjan Kr. Agarwal of Ranjan Bazar, PS Dubrajpur was coming to his Rice Mill in a M/Cycle after withdrawing cash Rs. 1,90,000/- from Axis Bank, Suri and reached near Dubrajpur Ranjan Bazar By-pass, 2 M/Cyclists intercepted him and robbed away said cash from his possession. This refers to Dubrajpur PS c/no 76 dt 29/5/09 u/s 392 IPC.
- xxv) On 1/6/09 around 11:40 hrs., 2 unknown M/Cyclists committed theft in respect of a hand-bag containing cash Rs. 1,50,000/- from one Kanak Mondal of Bhatsala, PS Ashokenagar, Dist N/24-Pgs. from Hutton Road More. This refers to Asansol South PS c/no 127 dt 1/6/09 u/s 379 IPC.
- xxvi) On 1/6/09 around 05:10 hrs., 4/5 unknown miscreants being armed with fire-arms looted away cash Rs. 30,50,000/- from one Sujit Kr. Ghosh of 15, Chandiberia Krishnapur, PS New Town while he alighted from the Car with Security near ATM Counter of Axis Bank at Baguiati 44 Bus Stand after assaulting said Security. This refers to Baguiati PS c/no 168 dt 1/6/09 u/s 395/397 IPC & 25(i)(a)/27 Arms Act.
- xxvii) On 1/6/09 night, a theft was committed in respect of cash Rs. 1,02,000/- and one Camera by some unknown miscreants from shop No.314 at South City Mall, PS Jadavpur. This refers to Jadavpur PS c/no 291 dt 2/6/09 u/s 379 IPC.

- xxviii) ON 2/6/09 around 15:15 hrs., 3 unknown miscreants entered into the office of the Extension Officer of Sericulture Firm committed robbery at the point of fire arms in respect of cash Rs. 1,70,343/- which was the undisbursed salary of the staff of aforesaid Firm and 4 mobile phones. The miscreants assaulted one Biplab Kr. Sarkar with fist and blows and they also opened one round fire from their fire arms at the time of retreat. This refers to Jhargram PS c/no 91 dt 2/6/09 u/s 394 IPC & 25/27 Arms Act.
- xxix) On 3/6/09 20 Nos of youths (18/25) being armed with fire arms came to the road side Hotel at Pirorgari More and started firing aiming the Police personnel while they were taking lunch at the said hotel. About 10/12 members of Extremist Group killed ASI B. Bera., C/1022 Bishnupada Saha and C/469 Gopal Ch. Dey by in discriminate firing and snatched away one Revolver Butt No.101 loaded with 6 rounds of ball ammunitions, one Rifle Butt No.570 loaded with 30 rounds of ammunitions, and SLR Butt No.20 loaded with 50 rounds of ammunitions from the possession of police personnel. This refers to Sarenga PS c/no 12 dt 3/6/09 u/s 353/333/332/326/307/396/120B/121/122/123/124A IPC & 25/27 Arms Act.
- xxx) On 8/6/09 around 13:30 hrs., a theft was committed by one unknown miscreants in respect of one bag containing cash Rs. 2 Lacs from one Sumit Chakraborty of Bud Bud Bazar. This refers to Budbud PS c/no 62 dt 8/6/09 u/s 379 IPC.
- xxxii) On 8/6/09 around 00:30 hrs., 10/12 unknown miscreants being armed looted away some goods worth Rs. 2 Lacs (approx) from the Go-down Cum Reserver of Khardah Municipality Missionpara Ward No.4 after assaulting duty staff one Khosman Ali. This refers to Khardah PS c/no 266 dt 8/6/09 u/s 395/397 IPC.
- xxxiii) On 8/6/09 around 13:00 hrs., one Kazi Abu Sufian of Banshgola, PS Lalbag, Dist Murshidabad along with others had been to Birohi "Asha Hotel" to purchase a Lorry No.WB-23A-4571 through a tout Sushil Biswas of Rajberia, PS Amdanga, Dist N/24 Pgs. During discussion one Jakir Mondal, Netai Mondal and Harab Mondal suddenly threatened them showing fire arms and snatched away his bag containing cash Rs. 2,05,000/-, one Cheque amounting to Rs. 50,000/- and 6 Pcs. of Mobile phones and fled away in a blue colour Maruti Van. This refers to Haringhata PS c/no 143 dt 8/6/09 u/s 392 IPC.
- xxxiiii) On 10/6/09 around 19:30 hrs., a theft was committed by some unknown miscreants in respect of some gold ornaments and cash Rs. 2,00,000/- from the house of one Jangu Prosad Paul of Baishali Kundu Bagan after breaking open the door of the house. This refers to Khardah PS c/no 271 dt 11/6/09 u/s 380 IPC.
- xxxv) On 11/6/09 around 05:20 hrs., some unknown miscreants robbed away cash Rs. 2,10,000/- and 4 Nos. of Mobile phones from one Parimal Roy of Joygachi, PS Habra on Prithibi Road at Uttar Baruni. This refers to Deganga PS c/no 192 dt 11/6/09 u/s 392 IPC.

- 2) This is a photograph of the dead body of an unknown male found lying at lower bank of river Ganges near Topcon Industries India Ltd. under PS Malipanchghara, District Howrah

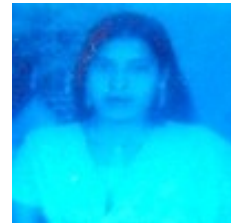

4. Interesting detections by CID, West Bengal

1) On 30/06/2009 at 17:25 hrs as per source information a raid was conducted by the officers and men of SOG Section, CID, West Bengal at north side gate of Science City and they arrested the following accused persons- i) Saifuddin Gazi (28 years) s/o Sahadat Gazi of Baligouri, PS-Minakha, District- North 24 Parganas ii) Hasanur Zaman (29 years) s/o Lt Khairul Zaman of village-Arialla, PO-Mirhati, PS-Barasat, District-North 24 Parganas and they recovered Rs.70,000/- FICN from their possession. This refers to Tiljala PS Case No. 197 dated 30/06/2009 u/s 489B/489C/120B IPC.

2) Some unknown miscreants sold the plots of land measuring about 2.39 acres under Jagadishpur Mouja by impersonating naming as Rup Kumar Bagui, Durga Das Bagui, Lakshminarayan Bagui and Sanatan Bagui and registration of deed were made in ADSR Bidhannagar on 15/05/2008. Thereby they misappropriated the sell proceeds of Rs. 1.1950 Crores by way of cheating. After prolong persuasion, total racket of the imposters have been detected and 6 accused persons including 2 impersonated Bagui brothers and impersonated Sanjoy Bagui were apprehended by officers of Cheating & Fraud Section, CID, West Bengal in the month of June 2009 in c/w East Bidhannagar Case No. 127 dated 23/09/2008 u/s 406/420/467/468/471/120B IPC.

3) One Deaf and Dumb boy named Nemai Das (12 Yrs.) S/o Kanailal Das of Tedubi, PO – Dhandalibar, PS – Contai was reportedly missing from his house on 20-09-08. Accordingly Contai PS GDE No. 1146 dt. 22-12-08 was lodged. Subsequently, MPB CID File No. 55-2009/ 7/ M (1) dt. 16-01-2009 was opened. The Photograph of the missing boy was circulated through Newspaper. On 18-06-09 one Tea Stall owner Tushar Das of Thanapara Road informed MPB, CID regarding the missing boy Nemai Das. Shri Tushar Das saw the photograph of missing boy in SANBAD PRATIDIN. Over this input of information Nandigram PS was asked to take charge of the boy and at the same time Contai PS was informed to collect his son from Nandigram PS. Thus the deaf and dumb boy has been recovered after lapse of almost 10 (Ten) months.

4) One Saswati Some @ Mampi (18) of Raigunj was reportedly missing on 08-05-09. from her private tuition Centre. Accordingly Raigunj PS GDE No. 353 dt. 08-05-2009 was lodged. In later course of time Shri Goutam Some father of the missing girl opened MPB CID File No. 55-2009/ 12A/ F (1) dt. 19-05-09. In course of enquiry information received that the girl had been seen near Bidhrohi Morh Raigunj, North Dinajpur. Accordingly a letter of recognition was issued addressing O/C Raigunj PS. Finally relatives of the missing subject went to Raigunj and with the help of local police the girl was recovered with her newly wed husband.

5) On 01-04-2009 one Sumit Biswas (16) of Aranghata, PS – Dhantala was reportedly missing from his house. A general diary was lodged at Dhantala PS vide GDE No – 100 dt. 03-05-09. Subsequently MPB, CID file No. 55-2009/ 2/ M/ 5 dt. 22-05-2009 was opened. On 30-05-2009 the informant Soma Biswas, mother of the missing subject received a phone call from a Telephone and Sumit talked over phone. The location of the missing subject was finally fixed as per source information and the boy was recovered from a tea stall of Sealdah where he was engaged as helping hand.

6) On 16-01-2009 one Anima Pramanik (17) was reportedly missing from her house. Her missing information was noted at Goyaltore PS GDE No. 620 dt. 17-01-2009. Subsequently on the basis of written information of Kashinath Pramanik MPB, CID File no. 55-2009/ 7A/ F (1) dt. 28-05-2009 was opened. In course of enquiry a call was received by Kashinath Pramanik from a Phone. As per source information the location was identified near from Chand Boral Street under Bartala PS Kolkata. Accordingly a letter of recognition was issued to O/C Bartala PS to trace out the girl. Finally the girl was traced from Sonagachi area.

7) On 05/06/2009, morning a team of CID West Bengal conducted raid on the basis of a source information at Betaitala GT Road Crossing, PS -Shibpur. During raid police party intercepted a TATA Sumo (white coloured) bearing registration number WB34 -G-2669 which was proceeding from Howrah side towards Kolkata side . On search 5 persons were found sitting inside the vehicle and five numbers of improvised fire arms were recovered from their possession. This refers to Shibpur PS Case No. 297 dated 15/06/2009 u/s 25(i)(a)/27 Arms Act.
