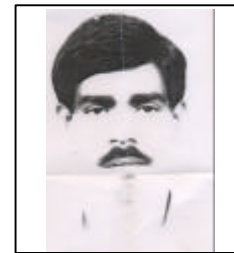

4) This is a photograph of the dead body of an unknown female found lying in the paddy field at Khajurnan, PS- Bagnan, Howrah with cut injury on her belly .

Description- Age 35 Yrs( approx), Built- Medium, Complexion – black , W/A- Red saree & red blouse , orange colour saya, white bra, blue jangia , one green check gamcha tied with her neck, This refers to Bagnan PS case No 127 dt 22/6/05 u/s 302 IPC.



5) This is a photograph of the dead body of an unknown female found floating in the pond located at Jungle , PS- Purba Midnapur.

Description- Age 30/35 Yrs( approx), Ht- 5'2'', Built- Medium, Complexion – fair , W/A- one torned blouse and rest uncovered , This refers to Bhabanipur PS case No 52 dt 9/7/06 u/s 302/201 IPC.



6) This is a photograph of the dead body of an unknown female found lying at the cultivation land of one Rahul Amin of vill- Maligram , PS- Habra, 24 Pgs (N).

Description- Age 23 Yrs( approx), Ht- 5', Built- Medium, Complexion – black , W/A- Black printed salwar and yellow kamiz , with which neck of the deceased was strangled. This refers to Habra PS case No 32 dt 11/2/06 u/s 302/201/34 IPC.

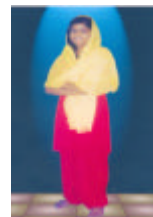
